#### V. <u>STAFF UPDATES</u>

- A. (Holly Martinez): While we were not renewed for the Women's Recovery Response program for \$7.9 million, we are receiving \$1 million, which will help sustain positions and support strategic contracts. The SB 24 budget which will be spent down through 2026.
  - a. We will be working to schedule the 2024 Commission Meeting dates with the new slate of Commissioners and will also be working on Committee assignments. These are typically assigned by the Chair and we can do a survey to get a sense of who would like to assist where. This will be a point of discussion for the September Executive Committee meeting.
  - b. Thank to Commissioner Baur-Kahan for acting as Chair.
- B. (Tifani Bartow) The Women's Recovery Response Grant program is moving forward, along with the College Student Right to Access Act program. We are working to hire new positions and those postings will be distributed when they become available.
- C. (Darcy Totten) We are starting to build international connections and relationships. We are developing a partnership with Girl Scouts, the California Budget and Policy Center regarding the Women's Wellness Index, and Blue Shield of California with plans to present to the Blueprint to their workforce.
  - a. (Commissioner Delaney) The social media metrics are down, do we have a solution?
  - b. (Darcy) One reason for this is that Twitter was taken down from our website due to changes at Twitter. We may be building new accounts on new platforms and may focus on getting more traffic to our website.

- D. (Kim Vaye) The Equal Pay program continues to partner with the First Partner's Office and engage more signatories. Equal Pay Day is in March and we are looking forward to another event in March of 2024. The next Equal Pay Day is Mom's Equal Pay Day. The next full Youth Advisory Council meeting is September 20<sup>th</sup>.
