#### III. EXECUTIVE OFFICER VACANCY

- A. (Rita Gallardo Good) Rita has been a 35- year public servant and has a strong track record of supporting women, and women of color, in the workplace, in college, and beyond. She is grateful for the opportunity to be selected at the finalist at the last Executive Committee meeting and looks forward to being considered.
- B. The vote for the Executive Officer vacancy will take place at the next meeting the week of April 22, 2024.

#### IV. STAFF UPDATES

A.Policy Committee

- 1. (Michelle) The policy subcommittee has met five times this year to discuss the bill proposal package and recommendations and have reviewed close to 30 proposals.
- 2. The Policy Committee previously recommended to adopt 13 bills and it was recommended to table two bills for further research, and now the two bills in question, plus one additional bill, are being recommended to include 14 total proposals.
- 3. Brief summary of AB 1863 (Ramos), AB 1908 (Schiavo) and AB 3031 (Lee and Low).
  - a. Unable to establish quorum, approval of meeting minutes will be moved to next meeting to be held the week of April 22, 2024
- 4. (Holly) We have secured a contract lobbyist, Political Solutions, who will be filling in for Michelle for her maternity leave.

#### **B.Grants Updates**

- 1. (Jen) Grant efforts are winding down for all 74 grantees and 12 discretionary grantees under the Women's Recovery Response program. Some organizations have requested extensions; however, the majority of final reports and expenditure summaries will be due April 12th. We are working to develop an impact report to showcase the incredible activities conducted throughout both years of this program.
- 2. Presentation on College Student Right to Access Act budget amendment.

#### C.External Affairs Updates

- 1. (Darcy) The Mount Saint Mary's Report on the Status of Women and Girls has been released and Holly represented us during a panel.
  - a. Mount Saint Mary's is an official partner of the Commission and additional reports will be released with them and we will hold two convenings a year with them.
  - b. The focus of the next convening will be on the Equal Rights Amendment.
  - c. The CA Budget and policy center is doing an update to the Women's Wellbeing Index.

- d. We sponsored Habitat for Humanity Women Build for a second year in a row.
- e. The Lean-In Girls MOU has been signed (leadership development program for girls 11-15) and they will be conducting facilitator training.
- f. We have formalized our partnership with all eight Girl Scouts Councils and will be working with them on an advocacy day patch project.
- g. Please reference the brand guide and the crisis communications plan in the meeting packet.

#### D.Programs Updates

- 1. (Kim) Thanks for everyone in their support to amplify Women's Equal Pay Day.
  - a. The Equal Pay Playbook is on our website.
  - b. Community Forward SF will be holding tours of their current facilities May 7, 2024- if you are interested in touring, please reach out to Kim.
  - c. We are working with CA Women Lead on their scholarships.
- 2. Youth Advisory Council Presentation on Girls Agenda; the focus areas are Education, Safety, Health. Recommendations are included in the meeting packet.
  - a. Unable to establish quorum; full vote on the Girls Agenda will be taken to the week of April 22 meeting.
