# V. Sexual Assault Advisory Committee - Action Items

- **a.** (Joelle Gomez) The Commission recommends a candidate to fill a vacancy who has a general services background for the Sexual Assault Advisory Committee. The Executive Committee recommends Ngozi Cameron Ashibuogwu.
- **b.** She has a background in being a domestic and sexual violence clinician, advocate and director and she'll help provide a different lens. She works as an Associate Director of sexual assault at UCLA's campus.
- **c.** (Nisha Devi Rodrigo) She had deep experience with survivors and policy. She was very well rounded.
- **d.** Yes- 9, No-0, Abstain- 0

### VI. Youth Advisory Council Update

- a. Programs Update: YAC Walk Through
- b. (Darcy Totten) Jen will be sharing an overall timeline of the Youth Advisory Council (YAC). This is an overview of the next two years of this program. More information can be found in the board packet.
- c. This is to get the YAC on the legislative calendar and get more focused on engaging the youth. We are in the process of sorting through 103 applications. These applicants applied to be in the 2025-2026 YAC class.
- d. We hope to gain 17 new candidates, and we will bring them to you in January.
- e. (Michelle Teran-Woolfork) We are excited to welcome Katherine Squire, she is going to help with the re-envisioning of the Youth Advisory Council.
- f. We tried to align the YAC calendar to line up with the legislative calendar.
- g. With this new class of members, they will be positioned to help decide where the focus should be in a policy level.
- h. This new class can help decide how to help in a legislative level, for example menstrual equity, in a five- or ten-year timeline and how to help with the implementation of bills.
- i. Once the class graduates, we can help celebrate any big victories that they have helped organize and establish.
- j. (Darcy Totten) We are establishing a period during which Commissioners will have the opportunity to mentor one or two members of the Youth Advisory Council. Participation is voluntary and will be available to Commissioners who express interest and have the availability in their schedules.
- k. We need to formally establish the YAC as that was not formally done previously.

- p. (Joelle Gomez) I want to say a nice welcome to Katherine.

### VII. Programs Update

#### a. SB 24

- i. (Jen DeGrossa) We are two years into the implementation of the SB 24 program. Medication abortion is now on-site at college campuses as part of this program. We want to be transparent; a report is due to the legislature at the end of the month.
- **ii.** There are two issue areas. CSU Maritime faces logistical challenges with providing healthcare. The campus has a conventional health center and serves students, but it also operates a vessel that spends two months at sea, where space limitations prevent the use of an ultrasound. Solutions include a new medical director joining Cal Poly SLO and a planned vessel upgrade that will accommodate the ultrasound equipment.
- iii. CSU Channel Islands offers a third-party provider on campus, including reproductive healthcare, but students in Ventura County must travel to CSU Northridge—40 miles away—for medication abortion services, as Ventura County does not provide this service. The university is facilitating transportation options like Ubers and Lyfts, but telehealth services are not available on campus.
- **iv.** (Michelle Teran-Woolfork) We are in initial conversations with figuring out what to do in 2025 with the new administration. This will be a top priority for the Women's Caucus. This will be a top discussion for this session.
- v. We have an opportunity to strengthen this legislation. We did have a conversation with the Attorney General and want to continue having these conversations. We want this access for our students and here to support and elevate.
- vi. (Darcy Totten) We do anticipate legislation for the Commission to vote on in January's meeting.
- **vii.** (Joelle Gomez) I want to thank you all for the leadership and this will be such a priority to stay on top of. Access is critical.

#### VIII. Policy Updates

# a. Legislative Updates & Political Solutions

- (Michelle Teran-Woolfork) Yesterday the legislature reconvened. It was a historic day; the Assembly and Senate welcomed a historical number of newly elected women legislators.
- ii. Both houses elected their leadership, Senator Mike McGuire who will continue to serve as Pro Tem. On the Assembly side, Assemblymember Robert Rivas will serve as Speaker.
- iii. Bill introduction will happen soon, so we will convene the Policy committee. On January 10<sup>th</sup>, the Governor will present his Budget Proposal.
- iv. (Darcy Totten) We are having earlier conversations so we should set aside a sizeable amount of time for these conversations.

# IX. External Affairs Update

- a. (Darcy Totten) We applied and filed for an exemption for the vacancy sweeps.
- b. We have continued to make efforts for the limited term positions. We will have more updates in early January.

- c. (Darcy Totten) There are a set of dates for some trainings contracted with CPS, this will be for Commissioners and staff. These trainings will be public, but they are all focused on trainings and team building.
- d. An internal SharePoint has been created for staff for more transparency in resources and formal trainings.
- e. There is a goal for 2025 to have a similar SharePoint for Commissioners.
- f. (Joelle Gomez) An email was sent out with details on the 2025 Committees. One specific change is making this a calendar year versus a fiscal year.
- g. These committees cannot make fiscal decisions or formal conversations without a conversation with the Commission. These committees will have to arrange meetings on their own but can still have staff support.
- h. The highlighted name is the Chair, and we also made the arrangement of the other committee member.
- i. (Erica Courtney) As we are trying to recruit members to these committees, there should be a one pager with more details. I have some examples of one pagers. By getting to this next step, we can start recruiting.
- j. (Darcy Totten) There is an action item attached to this; at the moment all committees are two people. From the by-laws, the Governance committee needs a formal Commission vote. [See official vote above]

#### k. Action Item

- I. Yes- 9, No- 0, Abstain- 0
- m. (Darcy Totten) We will be working with the Center for California Studies for a study on gender equity. They have agreed to fund this program.
- n. As part of the MOU, you are now all a part of the Center for Budget Center as members.
- o. (Justin McCoy) On the CCSWG webpage, you will find a video of the G20, a 5-minute video in front of attendees.
- p. The website is getting revamped and getting into compliance. We have an extension into June 2025; however, we have a timeline for January 20<sup>th</sup> with a focus on accessibility.
- q. (Darcy Totten) Justin is making us an entirely new website. Nothing is going away but finding much easier ways to find those resources. We will including a section for people who do not live in California and including resources.
