Executive Summary

Enclosed in the following pages, the California Commission on the Status of Women and Girls (the Commission) provides the detailed reports received from the University of California Office of the President, University of California Law San Francisco, and the California State University Office of the Chancellor. Each school system report includes an Executive Summary on general efforts undertaken by the school system over the past fiscal year, as well as activities, cumulative fiscal data, general state of readiness, and the number of medication abortion procedures provided at each student health center. This year, additional data sets on the cost to students for the provision of medication abortion have been included in these reports. It should be noted that the schools operate on their own fiscal calendars which differ among the systems. The UC system includes reporting from July 1, 2024 - June 30, 2025. UC Law San Francisco includes reporting activities from January 1, 2024, through June 15, 2025. The CSU system includes reporting activities from July 1, 2024 – June 30, 2025.

Medication abortion readiness has been reported as having been fully implemented throughout each school system in January 1, 2023, and the school systems are looking ahead to further anticipated activities and expenditures under this program, including capturing projects that are in progress or pending (and not yet billed for reimbursement), conducting facility and security upgrades, as well as ongoing training and consultation needs.

The Commission thanks the University of California Office of the President, University of California Law San Francisco, and the California State University Office of the Chancellor for their continued efforts under this Act, as well as the student organizers, advocacy organizations, Legislative partners, Governor's Office and staff and subject matter experts for their input and insight in the historic undertaking of making medication abortion services, a fundamental constitutional right, accessible to all students attending public university campuses.

Background and Legislative Reporting Requirements

The California Commission on the Status of Women and Girls is tasked by the California Legislature with administering the College Student Health Center Sexual and Reproductive Health Preparation Fund, providing non-monetary assistance and support, and fulfilling activity and expenditure reporting requirements.

Senate Bill 24 requires the Commission on the Status of Women and Girls to administer the College Student Health Center Sexual and Reproductive Health Preparation Fund, which the bill establishes, to provide private funding for statewide medication abortion readiness and implementation efforts across all state of California public University campuses. The bill continuously appropriates the monies in that fund to the Commission for allocations to each public university student health care services center for the purposes of specified activities in preparation for and provision of abortion by medication techniques.

This report is required pursuant to Senate Bill 24 (Chapter 740, Statutes of 2019), which is an act to add Chapter 5.5 (commencing with Section 99250) to Part 65 of Division 14 of Title 3 of the Education Code, relating to public health, and making an appropriation requirement. Senate Bill 24 (SB 24), hereafter referred to as the College Student Right to Access Act, requires, on and after January 1, 2023, each student health care services clinic on a California State University or University of California campus to offer abortion by medication techniques, as specified.

Senate Bill 24 requires the Commission to submit a report to the Legislature, on or before December 31, 2021, and on or before December 31 of every year thereafter until December 31, 2026, that includes, but is not necessarily limited to, specified information relating to abortion by medication techniques at these student health centers.

As identified in the legislation, the Commission reports on:

- 1) **The number of student health centers** that provide abortion by medication techniques.
- 2) **The number of abortions by medication techniques** performed at student health centers, disaggregated, to the extent possible, by student health center.
- 3) **The total amount of funds received by each system** and provided to the system's student health centers expended on medication abortion readiness, and, separately, the **total amount of any other funds expended on medication abortion readiness** and the source of those funds, disaggregated by function and, to the extent possible, disaggregated by student health center.

This data is provided in the Appendix for each school system.

As each school system has surpassed the initial readiness compliance requirements and is actively implementing the program, the Commission included the following additional supplementary questions for reporting to the Legislature:

- 1) **Other Fund Sources**
- 2) **Student Cost for Abortion Medication** at this Student Health Center
- 3) **Student Cost for Routine Medication Abortion Service** at this Student Health Center (this includes all necessary services, like pregnancy test, ultrasound, office visits, telehealth appointments, etc.)

Executive Summaries

University of California Office of the President (UCOP) Executive Summary

The following information has been provided by the University of California Office of the President. It has been edited for length and clarity.

All 10 campuses of the University of California (UC) system successfully implemented the provision of medication abortion in their Student Health Services (SHS) centers on January 1, 2024. The following systemwide measures were tracked from July 1, 2024, through June 30, 2025:

University of California Student Health Services centers (SHS) have fully implemented medication abortion services at each center. All campuses have an identified provider providing services at their location, either in person or through a telehealth arrangement. SHS intends, as the program continues, to conduct quality and patient satisfaction studies once it has achieved a significant number of procedures systemwide to assess the ongoing quality of its program. They will continue to provide high-quality access to these services.

The UC system has provided information regarding service implementation and the processes developed to coordinate service implementation systemwide. This year's report will summarize the cumulative fiscal data, the number of procedures reported by campuses, and ongoing implementation and enhancement work. UC SHS has implemented a systemwide Patient Satisfaction Survey for Medication Abortion services.

University of California Law San Francisco Executive Summary

The following information has been provided by the University of California Law San Francisco. It has been edited for length and clarity.

Since August 2020, University of California College of the Law of San Francisco (UC Law of SF) has partnered with Carbon Health to provide student health services to all UC Law of SF students at over 94 in-person locations or virtually. UC Law of SF's contract with Carbon Health is effective until August 2027.

As of January 1, 2022, Carbon Health has completed the implementation requirements of SB 24. Carbon Health's Vice President of Growth, Dr. Salvatore Mulè, oversees this service and ensures continued compliance with the requirements of SB 24.

California State University Office of the Chancellor Executive Summary

The following information has been provided by the California State University Office of the Chancellor. It has been edited for length and clarity.

All 23 campuses of the California State University (CSU) system successfully implemented the provision of medication abortion in their Student Health Services (SHS) centers on January 1, 2023.

The following systemwide measures were tracked from July 1, 2024, through June 30, 2025:

1. The CSU Chancellor's Office expanded their partnership with Essential Access Health to provide Pregnancy Options training for providers across the system.
2. A CSU workgroup was established to explore telehealth options to enable a sister campus to provide back-up services to smaller campus health centers when providers are unavailable.
3. CSU East Bay hosted sister campuses for on-site point-of-care ultrasound training.

Reports from Universities

University of California Office of the President (UCOP)

State of Systemwide Medication Abortion Implementation Efforts

All UC campuses have deployed medication abortion services. As stated in previous updates, UC has developed a standardized template for clinical documentation and patient experience surveys. Below is the number of procedures performed this year.

Ongoing Medication Abortion Implementation Efforts:

All UC Campuses provide services. There will be ongoing work on any deferred expenditures to complete the service buildout. This could include costs such as facility and security upgrades or other procurement items that take significant time to garner appropriate administrative approvals. The UC workgroup continues to develop standardized quality assurance and patient experience metrics to review individual campus progress. Since implementation has occurred, campuses are moving away from reporting implementation expenses and are now simply reporting these as annualized costs.

¹ UCSF no longer has a Student Health Services unit as of 5/31/2024. All students are seen by UCSF Health Primary Care Physicians and are provided access to UCSF Health's Women's Option Center. Medication Abortion is available through the campus Women's Options Center (with a free shuttle bus for all UCSF students).

Medication Abortion Implementation Expenditures

Cumulative reimbursements from the College Student Right to Access Act grant are shown in the table below. Grant expenditures include items such as facility upgrades, training, staff salaries, medical equipment, and one-time costs. The table below includes only actual reimbursed amounts.² UC anticipates further funds to be expended as deferred implementation activities resume and proceed.

Systemwide Support for Students

All campuses have adopted a Patient Satisfaction Survey. The collated responses were excellent, with high levels of patient satisfaction with the service. Not all campuses have been able to report data fully, as the response rates to the survey have greatly varied across campuses. We are working to establish best practices to make sure the data is valid.

Current data validated our earlier preliminary data, which found that all patients either found it helpful or extremely helpful to have the service available on campuses. Survey questions were on a five-point Likert scale. Most survey respondents were either very satisfied or satisfied with their experience. We will continue to monitor these surveys as a key metric for addressing any issues that arise in maintaining high-quality reproductive access care for our students at UC.

University of California Office of the President Closing Comments for Annual Report for SB-24 Implementation for FY 2024-2025

UC has successfully implemented the required provisions of SB-24 and is providing Medication Abortion Services to UC students at all campuses. UC continues to conduct regular reviews of this service, in line with its standard review procedures for UC Student Health Centers, with ongoing support from UC Health. The campuses expect to complete any deferred expenditure items in the upcoming fiscal year as this is the last year of the program.

University of California Law San Francisco

Since August 2020, University of California College of the Law of San Francisco (UC Law of SF) has partnered with Carbon Health to provide student health services to all UC Law of SF students at over 94 in-person locations or virtually. UC Law of SF's contract with Carbon Health is effective until August 2027.

As of January 1, 2022, Carbon Health has completed the implementation requirements of SB 24. Carbon Health's Vice President of Growth, Dr. Salvatore Mulè, oversees this service and ensures continued compliance with the requirements of SB 24.

The implementation of medication abortion techniques readiness has included clinical and operational training, partnership with approved third-party educators, and operational infrastructure enhancements:

- **Training:** Primary care physicians, nurses, medical assistants, central support and care navigators participated in a minimum of four hours of training per scope of care and related workflow requirements.
- **Partnership:** Third-party approved educator, Essential Access Health, was secured by Carbon Health to educate standards of care compliance and competency adherence.
- **Infrastructure:** Developed required administrative (e.g., workflow creation and deployment and patient educational materials) as well as proprietary EMR system product upgrades to support infrastructure for care delivery and compliance.

The initial cost of implementation was forecasted at \$173,000.00 with current, actual implementation cost at \$132,729.15. Both direct and indirect costs associated with implementation requirements were consistent with the allowable expenses noted by the California Commission on the Status of Women & Girls ("CCSWG"); details of associated costs are outlined below.

Ongoing Medication Abortion Implementation Efforts:

Access to medication abortion techniques is currently available at 12 locations (via in-clinic dispensing) and virtually (via prescription) by appointment.

Both direct and indirect costs associated with implementation requirements were consistent with the allowable expenses noted by the CCSWG. No other funds sources were appropriated to support the operational readiness for medication abortion techniques other than the reimbursement from UC Law SF upon submission of invoice as their third-party outsourced partner.

As of January 1, 2022, medication abortion techniques are considered fully integrated into the scope of care for women’s health at Carbon Health. Hence, on-going readiness is met systematically, e.g., regular hiring, routine onboarding process, primary care compliance, competency training (per policy standards of care guidelines), and scheduled clinical development training for relevant workstreams (which differ between medical providers and ancillary staff).

In addition to routine on-boarding and competency and compliance training, materials and on-going updates on medication abortion techniques are easily accessible via Carbon Health’s dedicated Policy and Training platforms that are actively managed by the Director of Primary Care Service Line and Program Manager.

Systemwide Support for Students

As a result of integrating this service into the CSU Student Health Centers, other opportunities for services have also grown including:

- The use of point of care ultrasound
- Increased obstetrics care
- The addition of gender affirming care

- Increased contraceptive options including Norplant and IUD
- The development of a medical shadowing program to support students needing hours to apply to medical school
- Increased health education outreach regarding reproductive health
- Improved patient satisfaction processes

California State University Office of the Chancellor Closing Comments for SB-24 Implementation for FY 2024-2025

The CSU continues to successfully implement the required provisions of the College Student Right to Access Act. Since medication abortion has fully integrated into the health centers, as can be seen above, many have reported unexpected benefits. The quotes below illustrate the impact on both providers and students.

Providers:

“Being able to offer MAB services to women has always been a positive experience. For the scared college student who had thoughts a pregnancy couldn't happen to them--- being able to offer my assistance to the patient so they feel in control of their decision making for an unplanned pregnancy is professionally rewarding. I am happy to offer my skills so that the patient knows what to do and what to expect with the MAB process.”

“I feel a sense of pride in being able to support students with their reproductive rights. They deserve nonjudgmental and empathetic care during this sensitive time in their lives.”

“I'm looking forward to continuing to provide high quality access to full reproductive healthcare and feel privileged to be able to do so. I'm also excited to continue advocating for funding for full sexual and reproductive healthcare access as the process of launching MAB has uncovered some clear need for students to have free or low-cost full spectrum care in these areas.”

Appendix 4: California State University Office of the Chancellor College Student Right to Access Act Activities and Expenditures

Summary of Activities:

The Office of the Chancellor has continued to partner with Essential Access Health to offer training to Student Health Center staff across the system, and in 2024-2025 began offering Pregnancy Options Counseling training. This is a nationally recognized certificate program that teaches participants to offer unbiased support and provide patient-centered options counseling that is informed by medically accurate information about pregnancy, parenting, adoption, and abortion.

The Office of the Chancellor also convenes the Student Health Center directors' group monthly. This group of directors and chief medical officers has shared best practices across the system and has collaborated across campuses to offer support to providers of MAB, especially regarding onboarding new providers. Members of this group have also worked to share resources and best practices, and offer training, such as the use of ultrasound, to campuses seeking this support.

FY 24/25 Summary of Activities:

In July and August of 2024, we finalized policies and procedures, patient education materials, and internal flow charts for medication abortion visits. Trained staff at front office and back office on the process of Medication Abortion and their roles and responsibilities. We tested templates in our electronic health records, made appropriate edits, and finalized the Medication Abortion Initial Visit template and Medication Abortion Follow up template. The Interim Director, who has extensive experience providing abortion services, educated the medical providers regarding the process of providing medication abortion and evaluated performance in mock medication abortion and follow up visits. We met with Peer Educators and provided an overview of the medication abortion services at SHCS and provided them with teaching tools. We met with SHCS psychologists to discuss abortion and medication abortion services offered at SHCS and the data about psychological impacts of abortion. We met with local abortion providers to finalize consultation and referral processes. We created referral documents for these services. We underwent a review of the security of our reception area and addressed staff concerns.
